The above counties are invited to participate, not all will. As of this time, there have been no requests to move amateurs into other counties but that may change the day of the exercise. Nothing has been promised at this point.

#### **Document Security**

The overall content, objectives, and participant list contained in this ExPlan are unclassified; however, information is restricted to use by exercise participants, trusted agents, and other individuals who have a need to know.

All exercise participants should be sensitive to security concerns. If, during the exercise, any participant becomes aware of a possible security problem (e.g., damage and loss of control over sensitive equipment, mishandling of classified materials, violations of laws), he/she is to notify a Controller immediately. Controllers should raise all potential security problems immediately to the Exercise Director, the Point of Contact (POC), or the Alternate POC.

#### **Rules**

- The Exercise Director will initiate exercise play by transmitting the start of exercise (STARTEX) message via the Controller communications network.
- The Exercise Director makes the decision to conclude the exercise, and transmit the end of exercise (ENDEX) message, based on completion of operations and attainment of exercise objectives.
- All communications (e.g., written, radio, telephone, e-mail) during the exercise will begin and end with the statement "Exercise, Exercise, Exercise."
- Real-world emergency actions take priority over exercise actions. "**Real-world emergency**" will be the designated phrase to indicate there is an emergency in the exercise area that requires immediate attention and may stop exercise play. Controllers will immediately suspend exercise play and evaluate the situation. The Exercise Director will then decide if the exercise can safely resume. Anyone who observes a participant who is seriously ill or injured will immediately notify the closest Controller, and, within reason and training, render aid.
- "Timeout" will be the designated phrase that Controllers use to temporarily stop exercise play.
- Exercise communication and coordination will be limited to participating exercise venues and the MCC.
- Participants will act in a professional manner at all times.

## Assumptions

Assumptions constitute the implied factual foundation for the exercise. Participants should account for these items before the exercise starts. The following general assumptions apply to this exercise:

- Exercise play will occur in real time; however, some events may require time jumps, and the SimCell will accelerate, or slow down, the schedule to meet exercise objectives.
- The exercise will occur in a no-fault learning environment wherein systems and processes, not individuals, will be evaluated.
- Exercise simulation will be realistic and plausible, and will contain sufficient detail to which Players can respond. The SimCell will provide sufficient information as available to simulate organizations or individuals not participating in the exercise.
- All participants will have an understanding of applicable policies, plans, and procedures to meet exercise objectives.
- Players will react to exercise events and information as if the simulated incident were real.
- Players and Controllers will use real-world data and information to the best extent possible.
- Players will not have prior knowledge of the scenario. Players who gain knowledge of the scenario prior to the exercise will notify an exercise Controller who will take appropriate actions to ensure a valid evaluation.

Artificialities are planning considerations that may deviate from standard procedures, but they exist to ensure Players safely meet exercise objectives. The following artificialities apply to this exercise:

- To minimize confusion with real-world activities, participants will use communication methods listed in the Communications Plan, which may differ from normal procedures.
- To meet exercise objectives, weather data provided will be different from actual weather conditions during the exercise.
- To minimize confusion with real-world activities, participants will use communication methods listed in the Communications Plan (see Appendix D for more information), which may differ from normal procedures. Participants will use real-world communications methods if alternate procedures are not specified in the Communications Plan.

## Expectations

### **Before the Exercise**

• Players will review appropriate policies, plans, procedures, processes, and exercise support documentation.

- Players will be at the appropriate site prior to STARTEX.
- Players will register or sign-in upon arrival.

#### **During the Exercise**

- Players should understand the scope of the exercise. If a Player is unsure about his/her individual or organizational role, he/she should direct questions to a Controller.
- Participants must recognize that unrealistic elements in the scenario may be required to satisfy exercise objectives within the constraints presented by the exercise format.
- Players will operate in accordance with existing plans, procedures, and practices from their respective organizations during the exercise. Players and Controllers will use current real-world data for resources and situation status unless otherwise provided.
- Players will speak aloud when taking action to make Evaluators and Controllers aware of their actions and facilitate data collection for exercise evaluation.
- Players and Evaluators will not engage in any conversation. If an Evaluator persists in talking to a Player, that Player will ask a Controller for assistance.
- Controllers will only provide Players with information specifically designated for dissemination. Players should obtain other necessary information through existing emergency information channels.
- Players will maintain a log of their activities when possible. This log may include documentation of activities missed by Controllers and Evaluators.
- Exercise Players who place telephone calls or initiate radio communications with the SimCell must identify the organization, agency, component, or individual with whom they wish to speak.
- Participants must adhere to all Controller instructions. With the exception of safety issues, the Controller has the authority to overrule participants. If there is a disagreement with the Controller, participants will complete the indicated action and make a note to discuss the disagreement at the end of the exercise during the critique.
- Players and Controllers will not engage in casual conversation. If a Controller asks a Player an exercise-related question, the latter will give a short, concise answer. If the Player is busy and cannot immediately respond, he/she will indicate as such, but will report to the Controller with an answer as soon as possible.

#### After the Exercise

- Players will participate in the Hotwash at the exercise facility with Controllers and Evaluators.
- All participants will complete the Participant Feedback Form.
